The Declaration will be done in two parts, one for the sender and the other for each reporter (AIF).

2.1 Introduction

The sender (= sending company) is in mandated to send reporting for a list of AIF. You have to declare the sending company's certificate used in e-file. The sender will send the declaration by email.

3 Reporter: postal mail

3.1 Introduction

For each AIF code (=reporter) declared at 2.2.2 a postal mail has to be sent to the CSSF in order to validate the sender.

As long as the postal mail was not acknowledge and validated by CSSF, the sendings may be refused.

Point 3.2.2 you will find the template to be printed with the AIF official letterhead and sent to:

Fields in blue are to be updated with information of the sender. Fields in green are to be updated with information of the AIF.
