## WHY IS ONBOARDING REQUIRED TO E-FILE?

### WHY IS ONBOARDING REQUIRED?

- To respect the controls put in place by the authorities
  - Which service provider/sender they expect for a given declaring entity
- To avoid rejection of a report after submission
- ... plus the advantage of having drop-down menus of the online forms prepopulated with the correct names/codification (once for all)






